## **OCCUPATION OF VACANT STALLS/BOOTH/SPACE**

### **CENTRAL FLACQ MARKET AND LALLMATIE FAIR**

1. In accordance with Section 57 of the Local Government Act 2011, the District Council of Flacq hereby invites Expressions of Interests from residents within the administrative area of this Council for the occupation of stalls at the above Market/Fair.

2. The successful applicant will also have to pay the appropriate annual fee.

3. The eligibility criteria are as follows:

- Applicant should be over 18 years.
- Applicant should be a resident within the administrative area of The District Council of Flacq.
- Applicant should be unemployed.
- Applicant should not already be holder of any stall shop or other place inside a market or fair or any other place of business.
- Applicant should undertake to occupy the stall personally.
- The minimum amount to be quoted for each booth/stall/space should not be:
  - (i) Less than Rs20,000/- for poultry, fish, meat at Central Flacq Market/Fair and Lallmatie Fair.
  - (ii) Less than Rs40,000/- for fruits and vegetable at Central Flacq Market.
  - (iii) Not less than Rs50,000/- for auction space and craft market at Central Flacq Market.

**Please note the quoted price will be one-off only and in addition the applicant will have to pay the annual fee.**

- The applicant selected to be allocated a stall in fruit/vegetable section in the fixed market at Central Flacq Market will also be allocated an additional stall for sale of fruits and vegetables in the Central Flacq Fair on Wednesdays and Sundays against payment of the yearly fee amounting to Rs8,400/-.

4. **Selection Criteria**

Stall/Booth/Space will be allocated to applicant quoting the highest amount. No selected applicant will be allocated more than one stall/space/booth despite quoting the highest bid. The Council may proceed for a drawing of lots if the need is required.

5. **Closing Date**

Application forms should be deposited in the Expression of Interest Box at the Administration Department, the District Council of Flacq, Plaine de Gersigny, Central Flacq on or before 15<sup>th</sup> February 2019 at noon at latest.

Application received after the specified closing date and time will not be accepted and considered.

Incomplete, inadequate or inaccurate filled Form will be rejected.

Applications not made on the prescribed form will be rejected.

6. **Submission of Applications**

Applications Forms in plain sealed envelopes should be addressed to the Chief Executive, The District Council of Flacq, Plaine de Gersigny, Central Flacq and deposited in the Expression of Interest Box at the Registry, Administration Department on or before 15<sup>th</sup> February 2019 at noon at latest. **Application Forms should not be sent by Post or by Fax.**

The Council reserves the right to accept or reject any interest expressed and the whole Expression of Interest Exercise without thereby incurring liability, whatsoever to those persons who have expressed an interest or inform of the grounds thereof.
