

# **District Council of Flacq (renting parking places for vehicles) Regulations 2017**

**GN No. 180 of 2017**

## **The Local Government Act 2011**

**Regulations made by the District Council of Flacq under Section 50, 158, 159, 163 of the Local Government Act 2011.**

1. These regulations may be cited as the **District Council of Flacq (renting parking places for vehicles) Regulations 2017**.

2. In these regulations

“Closing time” means the time the parking zone is not given access to any vehicle.

“Council” means the District Council of Flacq.

“Officer” means an Inspector of the District Council of Flacq or any other officer designated by the Chief Executive or a Police Officer.

“Parking Places” - The parking place shall be situated as follows:-

(i) Royal Road Central Flacq, Ex-Fair bordered by Traffic Centre, VIP Commercial Centre and Taxi Stand near Ex-Fire Station.

(ii) Market Road Central Flacq Ex-Market, near Flacq District Court.

“Parking Lot” means a space allocated to owner of vehicle for parking of his vehicle in the parking zone.

“Paid parking zone” means a part of parking area or a part of the road designated as such under regulation 3.

“Panel” means the panel specified in regulation 3(2).

“Reserved parking” means a parking lot, allocated to an owner of vehicle for a minimum period of one month.

“Vehicle” means any motor vehicle other than a motorcycle, an autocycle or a Government Vehicle bearing RM number or any vehicle belonging to the District Council of Flacq.

**3.** (1) The Chief Executive may designate any area as part of the parking lot or part of a road as a paid parking zone and may extend the operation time of the parking area.

(2) Every paid parking zone shall be indicated by one or more panels.

**4.** The panels:-

(a) shall be in form provided in first schedule, with any appropriate variation

(b) shall indicate:

(i) where appropriate, the limits of the paid parking zone.

(ii) zone number

(c) The days and time during which the paid parking zone is operational.

(d) The maximum permissible parking time.

**5.** Any person who parks his vehicle in a paid parking zone shall pay the parking fees for parking in a paid parking zone as specified in the first schedule.

**6.** (a) It shall not be lawful for any person to leave his vehicle in the parking zone after the closing time of the paid parking zone.

- (b) Any person leaving his vehicle after the closure of the paid parking zone will have to pay a penalty fee as prescribed in the first schedule. The Council will not be responsible for any vehicle left in the parking zone after the closing time.
7. It shall be lawful for the Council to rent a parking space to any owner of a vehicle for a minimum period of one month or more. The Owner should inform the Council, of his intention to have a reserved parking. The fees for reserved parking will be as per the first schedule.
8. (a) No motorcycle, bicycle, auticycle, carts shall be parked within a paid parking zone.
- (b) No person shall use a paid parking zone for any purpose other than for the parking of a vehicle.
9. Every vehicle entering the parking space shall be issued with a ticket indicating the time of arrival, waiting time will be calculated based on the ticket issued for payment at departure.
10. Parking of vehicle will be at the risk of the owner. The Council shall not be liable to any damage, loss, theft, fire caused to any vehicle parked in the parking zone.
11. Any person who contravenes any other provision made under these regulations shall commit an offence and be liable, on conviction, to a fine not exceeding Rs10,000.
12. The District Council of Flacq (renting parking places for vehicles) regulations 2013 is revoked.
13. This regulation shall come in force as from 1<sup>st</sup> July 2017.

2. (a) The parking will be operational as follows:-

Mondays to Saturdays                      7.30 hrs to 17.00 hrs

Sundays and Public Holidays 8.00 hrs to 17.00 hrs

(b) The Maximum permissible parking time for any vehicle would be 9.5 hours
