OCCUPATION OF VACANT STALLS AT LALLMATIE FAIR FOR SALE OF VEGETABLE, HABERDASHERY, FRUIT, GENERAL RETAILER (FOOD STUFF AND NON FOODSTUFF)

1. In accordance with Section 57(1) (a) of the Local Government Act 2011, the District Council of Flacq hereby invites Expressions of Interests from residents within the administrative area of this Council for the occupation of stalls at Lallmatie Fair for sale of vegetable, haberdashery, Fruit, General Retailer (foodstuffs and non-foodstuffs)

2. The eligibility criteria are as follows: -

- Applicant should be over 18 years.
- Applicant should be a resident within the administrative area of The District Council of Flacq.
- Applicant should be unemployed.
- Applicant should not already be holder of any stall, booth, space, shop or other place inside a market or fair.
- Applicant should not already be holder of any Trade Fee Receipt/Business Registration Card or any licence from any other authority.

The application forms duly filled in and should be submitted together with the photocopies of the following documents: -

- (1) National Identity Card**
- (2) Birth Certificate**
- (3) Proof of address (CEB, CWA or any other utility bill)**
- (4) Marriage Certificate (where applicable)**
- (5) Unemployment card**

3. **Mode of Application**

4. **Closing Date**

The closing date is on **28 March 2024 at Noon at Latest**

Application received after the specified closing date and time will not be accepted and considered.

Incomplete, inadequate or inaccurate filled Form will be rejected.

Applications not made on the prescribed form will be rejected.

5. **Mode of allocation**

Prospective applicant will be allocated only one stall

Prospective applicants will be allocated a stall in the relevant section subject to drawing of lots, which will be effected on a date, time and place fixed by the Council in presence of a registered usher or in such manner as may be determined by the Council.

6. **Fees Payable**

The yearly fees payable for a stall in any section whether vegetable, haberdashery, Fruit, General Retailer (foodstuffs and non-foodstuffs) is Rs 6,600/-.

7. **Submission of Applications**

Application Forms in plain sealed envelopes should be addressed to the Chief Executive, The District Council of Flacq, Francois Mitterrand Street, Central Flacq and deposited in the Expression of Interest Box at the Registry, Administration Department **on or before 28 March 2024 at Noon latest.**
Application Forms shall not be sent by Post or by Fax.

The Council reserves the right to accept or reject any interest expressed and the whole Expression of Interest Exercise without thereby incurring liability, whatsoever to those persons who have expressed an interest or inform of the grounds thereof.
