  - (c) Applicant should be unemployed
  - (d) Applicant should not already be holder of any stall/Booth/shop/space or other place inside a market or fair.
  - (e) Applicant should not already be holder of any trade fee receipt/Business Registration Card or any licence from any other authority **save and except for persons already found in the survey list of the Public Health Department for being holder of a Business Registration Card for Distributor of General Merchandise/ Owner of goods vehicles having `A` and/ or `B` Carrier licence or holder of any Business Registration Card for activities in relation to the existing Private fair including growing of vegetables.**
3. Applicants applying for booth to operate as: florist, handicrafts, hairdresser (Male/female,) shoemaker, Tailor (Male), Repair & sale of Mobile/Accessories should submit a registration certificate from Ministry of Industry Development, SMEs and Cooperatives.
4. Applicants are requested to call at the **Reception desk, District Council of Flacq, Francois Mitterand street vis a vis Super u, Central Flacq, to collect the Expression of Interest Document during office working hours or download the document from the website <http://www.flacqdc.mu>.**
5. The condition applicable for allocation of stall and the fees payable are specified on the Expression of Interest Document.
6. The duly filled forms together with the required documents should be deposited in the Tender Box at the Registry by the closing date on **31-October-2024** at latest.  
**Application received after the closing date and time will not be considered.**
7. All those who have previously applied for a stall by way of letter or otherwise should apply anew on the prescribed form.
8. The Council reserves the right to cancel this exercise and reject any application. No reason shall be assigned for the rejection.

  - (j) Applicant should not already be holder of any trade fee receipt/Business Registration Card or any licence from any other authority **save and except for persons already found in the survey list of the Public Health Department for being holder of a Business Registration Card for Distributor of General Merchandise/ Owner of goods vehicles having `A` and/ or `B` Carrier licence or holder of any Business Registration Card for activities in relation to the existing Private fair including growing of vegetables.**
  
3. Applicants applying for booth to operate as: florist, handicrafts, hairdresser (Male/female,) shoemaker, Tailor (Male), Repair & sale of Mobile/Accessories should submit a registration certificate from the Ministry of Industry Development, SMEs and Cooperatives.

- (2) Birth Certificate**
- (2) Proof of address (CEB, CWA/Telecom) bill- not exceeding 3 Month**

#### **4. Mode of Application**

The closing date is **31-October-2024 at noon.**

Application received after the specified closing date and time will not be accepted and considered.

6. **Mode of allocation**

Prospective applicant will be allocated only one stall except for activity 1, 3, and 4.

Prospective applicants will be allocated a stall in the relevant section subject to drawing of lots, which will be effected on a date, time and place fixed by the Council in presence of a registered usher or in such manner as may be determined by the Council.

7. **Fees Payable**

The yearly fees payable for a stall/ Booth in any section is as per the Bel Air Market/fair regulations.

8. **Submission of Applications**

Applications Forms with all relevant documents in a properly sealed envelopes should be addressed to the Chief Executive of the District Council of Flacq, Francois Mitterand street, Central Flacq and deposited in the Tender Box at the Registry, Administration Department **on or before 31-October-2024 at 12.00 hours at latest. Application Forms should not be sent by Post or by Fax or Email.**

**Incomplete, inadequate or inaccurate filled Form will be rejected.**

**Applications not made on the prescribed form will be rejected.**

**Applicants should apply for one item only and submit only one application.**

**The Council reserves the right to reject the application for those applying for more than one items and submitting more than one application.**

8. **Reservation**

The Council reserves the right to accept or reject any interest expressed and the whole Expression of Interest Exercise without thereby incurring liability, whatsoever to those persons who have expressed an interest or inform of the grounds thereof.
